Lighting update – TT Jones have now replaced the lamp outside the Community Centre, replacing the lantern and installing a timer. The Council are in conversation with the contractor about the possibility of shades to reduce the impact of lighting disturbing residents until such time as they are able to install timing on all the lamps the council are responsible for. This will also benefit wildlife and reduce the cost of electricity.

Flooding update – Highways have flushed the drains, and Highways Bridges have committed to checking the culverts either side of the Doctors Surger4.
